Information From Your Education Consultant Support Team

A quality education is key to a child's life-long success. Sadly, children in foster care are at a major disadvantage: 75% of children in foster care perform below grade level; only 15% graduate with a high school diploma; and foster children lose between 4-6 months of academic progress each time a placement changes.

Because a child's academic potential should not be limited by his or her experience in state custody, CASA Georgia hired Dmetria Gibson as Director of Education Advocacy in 2014 and launched a successful pilot Education Advocacy Project. More recently they have encouraged local CASA affiliates to increase the support they provide to their volunteers with school-age foster children. Providing back-up educational expertise to CASA volunteers is important because federal, state, and local education laws, policies, procedures and programs present a very complicated and ever-changing landscape. CASA volunteers may not be aware of available services and may benefit from guidance in navigating local schools to better advocate for their children.

Last spring, CASA/Glynn created a team of Education Consultants (EC's), who are trained CASA volunteers and professional educators. *Joan Boorman* (a CASA for 22 years) is a former Glynn County teacher and principal who currently teaches in the Education Department at CCGA. *Suzi Hassel* (a CASA for 3+ years) taught mathematics in Glynn County for 25 years. Judi Kelley (a CASA for one year) was a director of a program for children with emotional problems for nine school systems in Georgia; and *Mary Schellhorn* (a CASA for two years) was an educational administrator, school board member, and student counselor.

The EC's attended a daylong training program with Ms. Gibson from CASA Georgia, and they will continue their training with her next month. When the EC's began last spring, 109 of the CASA/Glynn children attended school. A review of the case files identified 65 students with educational concerns (ranging from low grades, not performing at grade level, behavioral issues, attendance problems, special education needs). Each of these 65 children (the children with concerns) was assigned to an EC who contacted the CASA to learn more about each student's education challenges and provide guidance, if requested. This fall, the ECs initiated contact with all CASAs with school-age children to introduce themselves and describe the support they are able to provide. Going forward, a child's educational status will be included in CASA monthly reports and in court and panel reports.

If you have not heard from one of our EC's about your school-age foster children, please expect a call or email. If there is a specific educational concern you would like to discuss with an EC, please contact one of them directly. And, if you are an educator and you would like to join the Education Consultant team, please let us know. It would be wonderful to add a few more educators to the group.
